- The educators demonstrate warmth, engage enthusiastically, and respond to each child's unique needs
- The centre fosters a sense of belonging through inclusive, familiar and loving daily interactions
- Educators are recognized for their professionalism, passion and consistent efforts that exceed expectations

Opportunities to enhance our program

In reviewing our scores and comments, the following have been identified as areas for enhancement:

- Improve timely and responsive communication with families
- Proactive event communication
- Facility maintenance re: parking lot issues

Next steps

- Create a parent communication protocol for when there are escalations in children's behavior and communicate this process to families so they know what to expect if a concern arises.
- Currently we send out event information in our monthly e-news and post outside the door a week before the event. We will start sending the event information by email at the same time as the e-news is sent.
- Facility maintenance regarding parking lot issues. The Lincoln Road Chapel has completed some patch work and are looking at a timeframe for paving of the parking lot within the next couple of years.
- A Digibot Parent app is in development. Once launched, it will support ongoing communication with parents.
